Early Advantage MBA Class 44 - Spring 2024

The total cost of tuition for **Early Advantage MBA Class 43 is \$87,944**. FoxPay is the official online student account and payment system for Rollins College and can be accessed through Foxlink or at https://foxpay.rollins.edu.

Tuition balance must be paid by 5 pm on the published due date or student will not be permitted to attend classes. Accounts with a past due balance of \$200 or greater will be subject to holds and a monthly late fee equal to 1% of the past due amount as outlined in the holds & late fee policy posted at www.rollins.edu/sas.

At the beginning of Term 1, students will automatically be billed the following one-time fees:

\$100 EAMBA Association Fee \$145 Parking Decal

The agreed tuition cost is maintained only as long as the student remains with the same cohort (EAMBA44). Students that withdraw and are approved to return to complete their program, will be charged at the current cohort tuition rate.
