

**PROGRAM OVERVIEW****Executive Doctorate in Business Administration Class 10 – Fall 2022**

The total cost of tuition for **Executive Doctorate in Business Administration Class 10** is **\$112,112**. FoxPay is the official online student account and payment system for Rollins College and can be accessed through Foxlink or at <https://foxpay.rollins.edu>.

Tuition balance must be paid by 5 pm on the published due date or student will not be permitted to attend classes. Accounts with a past due balance of \$200 or greater will be subject to holds and a monthly late fee. Tuition does not cover the cost of books, supplies, EDBA association fee, or parking decal.

At the beginning of Term 1, students will automatically be billed the following non-refundable one-time fees:

- \$200 EDBA Association Fee
- \$225 Parking Decal

**DIS 704 – Dissertation 4 is scheduled to be completed by the end of the program on August 31, 2025.** Any student that has not met this requirement will be continually registered for the course named **DIS 704 -Dissertation Continuation** for a total of 6 credit hours at the tuition rate of \$10,848 for every semester until completion for continuous advisement.

**Time Limitation** - EDBA students have five consecutive calendar years from the semester of the first credited registration, including leaves of absence, to complete all requirements for the degree. Any EDBA student who fails to complete the requirements within the five-year limit will be subject to separation from further study unless granted an extension by the EDBA Academic Committee subject to the recommendation of the student's faculty advisor or dissertation committee. An extension may be granted if the student and their advisor work out a plan of action for completion within an additional two-year time frame. The request must be made in writing by the student and supported by the advisor, then submitted to the EDBA Academic Director for consideration by the EDBA Academic Committee. Students who fail to complete degree requirements after 7 years will be automatically removed from the EDBA program.
