

PROGRAM OVERVIEW

Executive MBA Class 44 – Fall 2024

The total cost of tuition for **Executive MBA Class 44** is **\$75,000**. Tuition is billed on a per-term basis. Monthly billing statements are uploaded to the student’s FoxPay account located at <https://rollins.college/studentpay> and on [MyRollins](#).

Tuition balance must be paid by 5 pm on the published due date or the student will not be permitted to attend classes. Accounts with a past due balance of \$200 or greater will be subject to holds and a monthly late fee equal to 1% of the past due amount as outlined in the holds & late fee policy posted at <https://www.rollins.edu/student-account-services>.

The agreed tuition cost is maintained only as long as the student remains with the same cohort (EMBA 44). Students who withdraw and are approved to return will be charged at the current cohort tuition rate. **Tuition will cover the cost of e-books for the entire program.** Tuition does not cover the EMBA association fee, parking decal, supplies, or travel expenses associated with Global Immersion for Value Creation.

At the beginning of Term 1, students will automatically be charged the following one-time fees:

- \$200 EAMBA Association Fee
- \$145 Parking Decal

Refund Policy for Fall 2024 Only - The tuition deposit, association fee, and parking decal are non-refundable.

- Withdrawal before 8 am on August 15, 2024. 100%
- No refunds for MBA 550 after 8 am on August 15, 2024

After MBA 550 (percentage indicates remaining tuition balance minus \$3,750. Tuition for MBA 550)

- Withdrawal before 8 am on September 1, 2024 100%
- Withdrawal before 8 am on September 20, 2024. 50%
- No refunds after 8 am on September 20, 2024
