

## PROGRAM OVERVIEW

### FLEX MBA Class 02 – Fall 2023

The total cost of tuition for **Flex MBA Class 02 is \$63,898**. Tuition is billed on a per term basis. Monthly billing statements are uploaded to the student’s FoxPay account located in Foxlink and at <https://rollins.college/studentpay>.

Tuition balance must be paid by 5 pm on the published due date or student will not be permitted to attend classes. Accounts with a past due balance of \$200 or greater will be subject to holds and a monthly late fee equal to 1% of the past due amount as outlined in the holds & late fee policy posted at [www.rollins.edu/sas](http://www.rollins.edu/sas). Our experienced Financial Aid team is ready to assist students that would like to explore their financial aid options. Students should contact the Financial Aid Office directly through their site at <https://www.rollins.edu/financial-aid/index.html>.

The agreed tuition cost is maintained only as long as the student remains with the same cohort (FLEX 02). Students that withdraw and approved to return, will be charged at the current cohort tuition rate. Tuition does not cover the cost of books, association fee, parking decal, supplies, or travel expenses associated with the Global Business Experience.

At the beginning of Term 1, students will automatically be charged the following one-time fees:

- \$100 Association Fee
- \$145 Parking Decal

**Refund Policy for Fall 2023 Only** - The tuition deposit, association fee, and parking decal are non-refundable.

- Withdrawal before 8 am on August 23, 2023. . . . . 100%
- No refunds for MBA 500 after 8 am on August 23, 2023

After MBA 500 (percentage indicates remaining tuition balance minus \$2,229. Tuition for MBA 500)

- Withdrawal before 8 am on September 11, 2023. . . . . 100%
- Withdrawal before 5 pm on September 15, 2023 . . . . . 75%
- Withdrawal before 5 pm on September 22, 2023 . . . . . 50%
- No refunds after 5 pm on September 22, 2023

### Refund policy for Spring 2024 – Summer 2025

Tuition balance must be paid by 5 pm on the published tuition due date.

- Withdrawal before 5 pm on 1<sup>st</sup> Friday of the term. . . . . 100%
- Withdrawal before 5 pm on 2<sup>nd</sup> Friday of the term . . . . . 75%
- Withdrawal before 5 pm on 3<sup>rd</sup> Friday of the term . . . . . 50%
- No refunds after 5 pm on 3<sup>rd</sup> Friday of the term
