

## TUITION & PROGRAM OVERVIEW

### Early Advantage MBA Class 49 – Fall 2026 - AMP Students completing CLA requirements in May 2027

The total cost of tuition for **Early Advantage Class 49 AMP students is \$106,382**. Tuition is billed on a per-term basis. Monthly billing statements are uploaded to the student's FoxPay account located at <https://rollins.college/studentpay> and [MyRollins](#).

Tuition balance must be paid by 5 pm on the published due date or the student will not be permitted to attend classes. Accounts with a past due balance of \$200 or greater will be subject to holds and a monthly late fee equal to 1% of the past due amount as outlined in the holds & late fee policy posted at <https://www.rollins.edu/student-account-services/holds-late-fees/index.html>

The agreed tuition cost is maintained only as long as the student remains with the same cohort (EAMBA49). Students who withdraw and are approved to return, will be charged at the current cohort tuition rate. Tuition does not cover the cost of books, association fee, parking decal, supplies, or travel expenses associated with the Global Business Experience.

**The Refund Policy below is only applicable if the student withdraws from ALL classes.  
Tuition cost is set by term, regardless of credit hours taken.**

At the beginning of Term 1, students will automatically be charged the following one-time fees:

- \$100 EAMBA Association Fee
- \$145 Parking Decal

**Refund Policy for Fall 2026 Only** - The tuition deposit, association fee, and parking decal are non-refundable.

- Withdrawal before 8 am on August 25, 2026 ..... 100%
- No refunds for MBA 500 after 8 am on August 18, 2026

After MBA 500 (percentage indicates remaining tuition balance minus \$2,443. Tuition for MBA 500)

- Withdrawal before 8 am on September 14, 2026 ..... 100%
- Withdrawal before 5 pm on September 19, 2026 ..... 75%
- Withdrawal before 5 pm on September 30, 2026 ..... 50%
- No refunds after 5 pm on September 30, 2026
